**THE PARTICIPANT AGREES WITH THE FOLLOWING RULES, TERMS, & CONDITIONS:**

The participant agrees to abide by the rules and directives at all times while present at the venue.

- 1- No projectiles are to be thrown, kicked or otherwise to be made airborne by participants.
- 2- No participant shall engage in any behavior: a-likely to cause injury to themselves, other participants or employees/agents of Blue Ridge Battlefield Sports; b-likely to cause damage to the equipment or property of Blue Ridge Battlefield Sports, its agents or landowner; c-any other behavior deemed unacceptable by Blue Ridge Battlefield Sports.
- 3- Blue Ridge Battlefield Sports may require any participant engaging in unacceptable behavior to leave the venue.
- 4- Each participant must remain within the designated boundaries of the Battlefield venue at all times.
- 5- Each participant will be required to wear the following: a-long pants covering the entire leg; b-enclosed shoes protecting the toes; c-hats, caps or headbands provided by Blue Ridge Battlefield Sports; d-any other safety devices deemed necessary by Blue Ridge Battlefield Sports.
- 6- Any participant that refuses or is unable to comply with these rules will not be permitted to participate.
- 8- Any participant that is injured, or observing another player injured, shall immediately notify the staff of Blue Ridge Battlefield Sports of the incident.

**RELEASE & DISCHARGE**

The participant releases, discharges, waives and forever holds harmless Blue Ridge Battlefield Sports for all claims for any loss sustained by the participant whether caused by negligent act or willful act or omission, breach of contract, breach of statutory duty or otherwise in connection with Blue Ridge Battlefield Sports. The participant agrees to Blue Ridge Battlefield Sports taking photographs or other images while participants are at the venue and to develop, reproduce and use them royalty free for any purpose (including commercial advertising). Participant gives authorization to seek medical attention on their behalf in case of an injury.

**WARRANTY AS OF AGE**

By personally executing this deed, the participant warrants that he or she is at least eighteen (18) years of age. Where this deed is executed by a parent, guardian, or other person for and on behalf of the participant, the person so executing warrants that he or she has the authority to do so and agrees to indemnify Blue Ridge Battlefield Sports in terms contained in Release & Discharge clause.
